Requirements & Fees

The estimated initial investment for one BV~II~GO can vary from \$230,000 to \$315,00 depending on location and building size, minimum of 1500 sq. ft. We will consider both single and multi-unit development agreements.

This amount includes everything you need to start your operation and also includes the \$30,000 Franchise Development Fee. CONFIDENTIALITY AGREEMENT

In connection with your request in becoming a franchise in the BV~II~GO System, _____ (“Company”) and/or its employees, recognize and understand that Buena Vista Café Restaurant, Franchise System Limited, will entrust Company, and/or its employees, with information consisting of knowledge concerning the systems of operation, services, products, trade secrets, recipes, clients or customers of BV which BV has developed and assembled at great effort and expense, and which information is not public knowledge, but which is confidential, proprietary business information of BV. (“Confidential Information”).

Company and/or its employees, specifically understand that BV Operating Manual, the systems of operation, service, products, trade secrets, recipes, clients or customer lists, financial information, sales information, marketing techniques, vendors list, costing and pricing data, accounting materials, and all other materials designated by BV, as “Confidential” constitute “Confidential Information”.

Company and/or its employees, shall not at any time use, copy or disclose any Confidential Information, in whole or in part, except as authorized by BV nor otherwise make the same available to any person, whatsoever, except with prior written consent of BV. If you select not to proceed to become part of the BV~II~GO system, or if you are not accepted by BV as a franchise, you agree immediately to return all confidential information in its possession and immediately discontinue any use of the Confidential Information. Company shall use its best effort to protect the Confidential Information from being disclosed contrary to this agreement.

Company understands and agrees that the unauthorized disclosure of the Confidential Information contrary to this agreement shall damage and cause irreparable harm to BV, and that BV shall in addition to any and all remedies available at law or in equity be entitled to seek and obtain a court injunction prohibiting any such violation as well as future violations.
